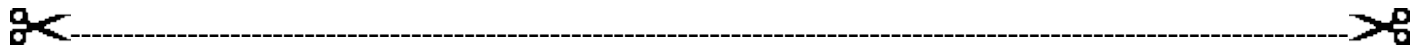

FEES: **\$25 Registration** (per student, non-refundable) Due Now – (payable to SGPA)

**\$45-\$140 Costume Fee** (per student) Due September 1, 2010 – (payable to SGPA)

**\$50 Spring Concert Fee** (per family) Due February 1, 2011 – (payable to SGPA)

Tuition is based on 36 weeks of instruction and is divided into 10 equal payments. Tuition is due on the 1<sup>st</sup> class of each month. It is considered late by the 10<sup>th</sup>. **As of June 1st, 2010, SGPA will require automatic billing due to policy updates.
